1. The Before School program is offered Monday-Friday, and will begin on Tuesday, August 13, 2019. The After School Program runs Monday-Thursday, and will begin on Tuesday, September 3, 2019 (except for specified days). The After School Program will end on April 30, 2020, budget permitting. You will be notified by auto-dialer, newsletters, and flyers home of the dates that we will not have After School.
2. Students that submit an application are accepted in the program unless informed otherwise.
Students may only attend the Before/After School program after they have completed and turned in an application.
3. **Late pick up policy:** The Before/After School Program starts at 4:10 p.m. and finishes promptly at 5:20 p.m. **Students must be picked up no later than 5:30 p.m.** After the third late pick-up, the student will be dismissed from the program.
4. The Before/After School Program is an extension of regular school hours. The same procedures and guidelines for behavior apply, as during the school day. **After two referrals, the student will be dismissed from the program.** Fighting, bullying, stealing, damage of school property or any other serious offense will result in student immediate dismissal from the program.
